## **POSITION OVERVIEW:**

The Probation Support Technician is a temporary 6-month, full-time position that will be evaluated for extension every six months dependent on budgetary and workload needs. Because this is a temporary position, it is <u>not</u> accompanied by a full benefits package.

## **REPRESENTATIVE DUTIES:**

- Perform receptionist duties by greeting visitors/clients in person and via telephone, answering routine questions, and directing visitors/callers to the appropriate person or department.
- Responsible for collecting fines and restitution payments, logging the same and forwarding to the U.S. District Court Clerk's Office.
- Screen and route incoming mail and prepare outgoing mail for delivery.
- Make copies of documents for distribution or filing.
- Upload documents and case files into a document imaging case management system.
- Deliver and pick-up documents and distribute faxes.
- Adhere to all human resources policies and the Code of Conduct for Judicial Employees.
- Perform other duties as assigned.
